Information designed to assist tribes to make research/evaluation decisions that support tribal sovereignty. While the primary focus is on genetic research, the same protocols can apply to other research and evaluation efforts. Tribes can use this guide to help define guiding values, decide if participation in research is right for them, and review cases and examples of research agreements and tools from other tribes.
